### CLUB HONOURS POLICY

The purpose of this policy is to provide a framework for the nomination, assessment, and selection for Members of the Coogee Beach Surf Life Saving Club (SLSC) Honour Awards. It outlines the procedure by which nominations are processed as well as giving a broad set of criteria that shall be used when assessing the suitability of those members to be awarded Club Honours.

# 1. PRINCIPLE

To acknowledge the dedicated and selfless contribution of members who have provided:

1. Outstanding contribution throughout the season in the delivery and development of Club Administration, Surf Life Saving and Surf Sports Activities.
2. Extensive years of distinguished voluntary service to the Club over a sustained period in various aspects of Club related activities which includes but is not limited to Governance, Beach Operations, Club Operations and participation in Club Events and Social Activities or by virtue of a Meritorious rescue performed by a member or members.
3. Dedicated and selfless contribution of members who have provided extensive years of extraordinary voluntary service to the City of Cockburn by extending them the honour of being awarded life membership of the Coogee Beach SLSC

# 2. SCOPE

This policy covers the Members of the Coogee Beach Surf Life Saving Club and is written to incorporate requirements of the Coogee Beach SLSC Constitution.

# 3. DEFINITIONS

The definitions of the Coogee Beach SLSC Constitution are adopted within this policy.

# 4. HONOURS PANEL

The Honours Panel shall be constituted by clauses within this policy and will meet within two (2) weeks of nominations closing and shall have the authority to award Club Honours and co-opt the services of other persons to provide advice and assistance on specific matters referring to the nomination.

Review the achievements of the nominees in accordance with the criteria set out in this policy and ensure that clarification and verifications of a nominee's achievements, activities, offices held, roles and responsibilities are provided in their assessment.

The Honours Panel doesn't have the authority or power to make decisions binding on the Board or Association.

Composition of the Honours Panel will be comprised of the eight members detailed below, with a quorum of five required.

- Chairperson – Appointed annually by the Board of Directors
- Board of Directors Representative/s - (Appointed annually by the Board of Directors)
- Panel Administrator (Appointed annually by the Board of Directors)
- Life Members x 5

On awarding Club Honours, the Honours Panel is responsible for compiling and submitting Club nominations for the SLSWA Awards of Excellence.

## 4.1. RESPONSIBILITIES

- Honours Panel are required to produce minutes of any meeting held and must maintain confidentiality of nominees.
- Ensure that factual information and documented evidence regarding the nominee's achievements, offices held and so forth shall be sourced and verified. This may include, without limitation archival documentation in the form of minutes of meetings, annual reports,

honour boards, certificates. Letters etc. Where this is not possible. Relevant information shall still be listed, and details provide.

- Honours Panel Chairperson shall ensure that clarification and verifications of a nominee's activities, offices held, roles and responsibilities are provided in their assessment. This is to allow the Panel to make an informed assessment of the nominee's achievements.
- Honours Panel to provide the Board of Directors a written submission of appointments of Life Membership for the Boards approval. The submission shall provide an overview of the assessment of the nominee's achievements, activities, offices held, roles and responsibilities.
- Honours Panel Chair or a representative appointed by the Chair shall, at the request of but in the absolute of the Board, attend a scheduled Board meeting for clarification of an appointment.

## 4.2. NOMINATION, REVIEW AND AWARD PROCESS

Nomination closing dates for each honour will be set at the Board of Directors Annual Planning Day (held in July) and communicated to Members via the Club's Website and Newsletters.

Nominations for the following Club Awards are compiled and submitted online by Members of the Club, members can submit (apart from Life Membership) one nomination per award category:

Details of the nomination process are defined in:

- Attached 1 Life Membership Process Flow
- Attachment 2 Club Awards Process Flow

If there are no nominations submitted by the requested due date for an honour, the honour will not be awarded for that particular season.

The nomination, review and selection of the awards shall be in line with the relevant clauses in the Club Honours Policy and takes precedent over other procedures and documents.

## 5. HONOURS

### 5.1. LIFE MEMBERSHIP

Life Membership is the highest award available to be bestowed upon an individual of the Coogee Beach Surf Life Saving Club. Life Membership recognises the exceptional and extraordinary voluntary contribution of an individual to the Coogee Beach Surf Life Saving Club.

- Nomination is to follow the Life Membership Process Flow. (Attachment 1)
- Nomination shall be made by any two (2) financial members of the Association.
- If a nomination is unsuccessful, it is able to be updated and resubmitted for consideration after a minimum of two (2) years from the date the final motion is rejected.
- The onus is on those Members nominating the Member for life membership to provide all relevant information and documentation in support of the nomination.

#### CRITERIA

- At least fifteen (15) years of active service, the voluntary service rendered and the achievements during that period must be considered as extraordinary.
- Consistent, sustained, exceptional and extraordinary voluntary service or achievement and exemplary contribution that is beyond what is expected of Association Members.
- The service and achievement must primarily be for the benefit and/or advancement of the Association. Service and achievements within SLSWA or SLSA may also be considered as contribution to the nomination.

- Contributions made by the nominee to the Association can be wide and varied and all of these must be considered, the number, type of positions, demands of each position and the period for which they were held should all be considered.
- Competitive record including local, State and/or National representation may also be considered as contributing to the nomination of Life Membership.
- The nominee shall have shown to have abided by the Code of Conduct of SLSA, SLSWA and the Coogee Beach SLSC. The nominee must have exhibited professional, ethical, and positive conduct during their Membership of the Association.
- In special and extenuating circumstances, the Honours Panel by unanimous decision may recommend to the Board of Directors, Life Membership of the Club to any member who warrants this honour due to rendering special and outstanding service to the Club, without the requirement of fifteen (15) year's membership, but this would be for exceptional circumstances only and must not be for more than one nomination per annum.

## 5.2. DISTINGUISHED SERVICE AWARD

To acknowledge members who have rendered distinguished service to the Club over a sustained period (no less than 10 years of active service) in various aspects of Club related activities which includes but is not limited to Governance, Beach Operations, Club Operations and participation in Club Events and Social Activities or by virtue of a Meritorious rescue performed by a member or members.

A maximum of 6 distinguished service awards may be issued in any one season. The Honours Panel shall be responsible for identifying and recommending members for the award to the Board of Directors.

### CRITERIA

- At least ten (10) years of active service rendered in various aspects of Club related activities which includes but is not limited to Governance, Beach Operations and Club Operations.
- The number and types of positions held and the period for which they were held.
- Participation in Club Events and Social Activities. (i.e., Fundraising activities and Club Open Days)
- Meritorious rescue performed.

### REFERENCES

- Active Service - when a member takes on an “**Active**” Role within the Club (i.e. Patrolling Member, Director or Club Office Role)
- Governance: Board of Directors
- Beach Operations: Lifesaving & Training, Member Development (Nippers & Youth), Surf Sports
- Club Operations: Administration, Club Development, Marketing
- In determining a member’s qualification for this award, the Honours Panel will consider the seniority of each position held as follows:
  1. Director
  2. Patrol Captain & Age Group Manager
  3. Coordinator & Vice Patrol Captain
  4. Club Officer
  5. Patrolling Member/Surf Sports Competitor

The panel will have the complete discretion to determine a member's qualification as it sees fit.

### AWARD PROCESS

The Director of Administration will run a report annually (February) in SurfGuard to identify members with service greater than 10 years of service.

Report to be forwarded to the Honours Panel Chairperson who will populate any missing data and present the report to the Honours Panel for evaluation and award. (Members may also be nominated for life membership if service is deemed as exceptional service to the Club)

Honours Panel Chairperson to present the Honours Panel recommendations to the Board of Directors for approval.

### 5.3. CLUB PERSON OF THE YEAR

Geoff Newman Club Person of the Year Award is the highest awards available to be bestowed upon an individual of the Coogee Beach Surf Life Saving Club in a season.

Recognise an individual member/s who has demonstrated achievements in a range of different areas of the club throughout the season, or who has shown significant and outstanding achievements in one particular area for an extended duration. The individual's contribution demonstrably enhances the development of the Club.

A nominee may be a member in any area of the Club including but not limited to Governance, Lifesaving & Training, Member Development (Nippers & Youth) and Surf Sports.

#### CRITERIA

- It recognises the exceptional service of an individual to the Club.
- Services rendered and the achievements during the season must be considered as distinguished.
- Consistent, sustained, and dedicated service or achievement and exemplary contribution that is beyond what is expected of Club Members.
- Service and achievement must primarily be for the benefit and advancement of the Club. Service and achievements within SLSWA or SLSA may also be considered as a contribution to the person's nominations.
- Contributions made by the nominee to the Club can be wide and varied and these must be considered. The number, types of positions, demands of each position and the period for which they were held should all be considered.
- Competitive record including Local, State and/or National representation may also be considered as contributing to the nomination for the Club Person of Year Award.
- The nominee shall have shown to have abided by the Code of Conduct of SLSA, SLSWA and the Coogee Beach SLS. The nominee must have exhibited professional, ethical, and positive conduct during their Membership of the Club.

### 5.4. CLUB FAMILY OF THE YEAR

Murray Club Family of the Year Award recognises a family group (of two (2) or more family members) who have demonstrated achievements in a range of different areas of the club throughout the season, or who have shown significant and outstanding achievements in one particular area for an extended duration. The family's contribution demonstrably enhances the development of the Club.

A family's nominees may be members in any area of the Club including but not limited to Governance, Lifesaving & Training, Member Development (Nippers & Youth) and Surf Sports.

#### CRITERIA

- It recognises the exceptional service of a Family to the Club.

- Services rendered and the achievements during the season must be considered as distinguished.
- Consistent, sustained, and dedicated service or achievement and exemplary contribution that is beyond what is expected of Club Family Members.
- Service and achievement must primarily be for the benefit and advancement of the Club. Service and achievements within SLSWA or SLSA may also be considered as a contribution to the family's nominations.
- Contributions made by the family to the Club can be wide and varied and these must be considered. The number, types of positions, demands of each position and the period for which they were held should all be considered.
- The family shall have shown to have abided by the Code of Conduct of SLSA, SLSWA and the Coogee Beach SLSC. The family members must have exhibited professional, ethical, and positive conduct during their Membership of the Club.

### 5.5. NIPPER OF THE YEAR

Recognises an individual Nipper (U10 to U13) who has contributed and demonstrated outstanding achievements in the areas of individual safety, surf awareness, lifesaving, and surf sports within the Club and the Surf Lifesaving Community. The Nipper's contribution to the Club demonstrably enhances the development of the Club's Nipper Program.

#### CRITERIA

- Achievement of individual safety outcomes as prescribed in the Woodside Nipper Program.
- Achievement of surf awareness outcomes as prescribed in the Woodside Nipper Program.
- Achievement of the lifesaving outcomes as prescribed in the Woodside Nipper Program.
- Achievement of the surf sports skills outcomes as prescribed in the Woodside Nipper Program.
- Attitude displayed by member e.g., positive, tries their best, team orientated, respectful, role model.
- Level of participation of member – attendance on Sundays, at training, at carnivals
- Contribution to club.

### 5.6. YOUTH OF THE YEAR

Recognises an individual Youth Member (U14 to U17) who has contributed and demonstrated outstanding achievements in the areas of lifesaving, training, leadership and surf sports within the Club and the Surf Lifesaving Community. The Youth's contribution to the Club demonstrably enhances the development of the Club's Youth Program.

#### CRITERIA

- Achievement in lifesaving area – hours on patrol to date this season, awards gained during the season.
- Achievement in training area – assistance provided to training area; training award gained.
- Achievement in leadership area – leadership activities undertaken, registered for YLP.
- Achievement in surf sports area – club, interclub, coaching, officiating.
- Attitude displayed by member e.g., positive, tries their best, team orientated, respectful, role model.
- Level of participation of member – attendance on Sundays, at training, at carnivals.
- Contribution to club.

### 5.7. LIFESAVER OF THE YEAR

Recognises an individual member who have made an outstanding contribution to the delivery and development of surf lifesaving frontline services, aimed at active surf lifesavers undertaking

lifesaving duties and who can be presented as an identifiable "Ambassador or Ambassadors" for surf lifesaving within the Club and Community.

### CRITERIA

- Individual contribution and commitment made to surf lifesaving patrol duties.
- Demonstrated commitment to public and community safety.
- Positions held relevant to lifesaving, held at Club, State and National levels.
- Awards achieved relevant to surf lifesaving duties.
- Attended conferences and participated in professional development relating to education.

### CATEGORIES

- John Bate Junior Life Saver of the Year
- City of Cockburn Life Saver of the Year

## 5.8. PATROL OF THE YEAR

Recognises individual Patrolling Members who have made an outstanding contribution during the course of the season in the delivery of lifesaving services and can be presented as a "Ambassador" for Lifesaving activities within the Club and the Community.

- Patrol of the Year Squad selected – early April
  - Number selected in the squad will be based on the number of Patrolling Members who met the patrol hours criteria for the season by the end of March.
- Patrol of the Year Squad communicated to the Club's membership base – this will promote the award and encourage Members to attend the annual dinner.
- Patrol of the Year finalised – end of April
- Patrol of the Year announced at the Annual Dinner

## 5.9.500 PATROL HOURS CLUB

Recognises individual Patrolling Members who have obtained 500 patrol hours of service with the Club.

### CRITERIA

- Cumulative patrol hours served with Coogee Beach SLSC WA exceed 500 hours.
- Assessment is undertaken after the conclusion of each patrol season.
- SurfGuard is the official record of patrol hours; prior to the recording of patrol hours in SurfGuard, manual patrol logs are the official source.
- Eligible candidates shall meet the requirements regarding their conduct and remain in good standing with the Club as outlined in CB040 Members Code of Conduct.

## 5.10. EXCELLENCE IN MEMBER DEVELOPMENT

Dave Knowles Excellence in Member Development Award recognises an individual member who have made an outstanding contribution towards the areas of Education, Nippers and Youth within Surf Lifesaving and the Community.

### CRITERIA

- Outstanding contribution and commitment made to the delivery of Surf Lifesaving Training, Nippers and Youth Programs within the Club and Community.
- Contributed to the continuous improvement of new Education Resources, Nippers, and Youth Programs.
- Positions held relevant to Education, Nippers, and Youth, held within the Club, State and National levels.
- Awards achieved relevant to Education, Nippers, and Youth Programs.
- Attended conferences and participated in professional development relating to Education, Nippers, and Youth.

## 5.11. SURF SPORTS PERSON OF THE YEAR

Scott and Michelle McKee Surf Sports Person of the Year recognises individual member who have made a significant contribution towards the area of Surf Sports within the Club and the Surf Lifesaving Community. In a range of a number of different Surf Sports disciplines throughout the season, or who has shown significant and outstanding achievements in one particular discipline for an extended duration. The individual's contribution demonstrably enhances the development of Surf Sports within the Club and the Surf Lifesaving Community.

### CRITERIA

- Contribution and commitment made in development of the Surf Sports culture within the Club and the Surf Lifesaving Community.
- Demonstrates a positive image with sound coaching and planning principles and has made a significant contribution towards the improvement of a Surf Sport discipline/s performance either at an individual or team level.
- Positions held relevant to Surf Sports, held at Club, State and National levels.

- Awards achieved relevant to Surf Sports activities.
- Attended conferences and participated in professional development relating to Surf Sports.

### 5.12. COMPETITOR & TEAM OF THE YEAR

Recognises competitors and teams who have achieved sporting excellence in competition as well as contributed to the area of surf sports within surf lifesaving during the season. Areas taken into account may include performance in major competitions or competition series, participation in representative teams, and any other areas where the nominee has made an important contribution to Surf Life Saving.

#### CRITERIA

- Competition results.
- Demonstrated a positive image to other members and teams within the Club and at competitions.
- Contribution and commitment made to competitions within surf sports.
- Attended training and development sessions relating to competitions.

#### CATEGORIES

- Adaptive
- Nipper (U10 to U13)
- Youth (U14 to U17)
- Adaptive (All Ages)
- Open (aged 18 or older)

### 6. VOLUNTEER OF THE MONTH

Coogee Beach Surf Lifesaving Club Inc. (CBSLSC) recognises that volunteers are a vitally important part of the Club and will recognise and reward hard working volunteers through the Volunteer of the Month Programme. Volunteer nominees can come from any area or level of expertise within the Club with no boundaries limiting their ability to be awarded the Volunteer of the Month.

#### NOMINATION AND AWARD PROCESS

- Nominations are submitted on the electronic form and close on the third (3) Friday of each month.
- Nominations circulated by the Honours Panel Chairperson to the Honours Panel for review and selection of the Volunteer of the Month.
- Honours Panel Members award votes to the respective nominations 3, 2 & 1 and email their votes back to the Honours Panel Chairperson (Chairperson doesn't vote)
- Votes are tallied (Chairperson has the casting vote if required)
- Volunteer of the Month details email to the President and Director of Administration.
- Award presented by the relevant Director in front of the Volunteer peers and Club Members

### 7. INTERPRETATION

All members of the Association should endeavour to assess and decide upon the nomination for Life Membership in line with the plain language/English intent of the Constitution and this Policy.

It is recognised that assessment of a nomination in relation to all criteria is ultimately a subjective process. This is due to the assessment being made by individuals who may have differing values and beliefs.



# 8. AWARDS, ROOMS & EQUIPMENT NAMING

Naming of an award, room, or a piece of equipment after a Club Member is to acknowledge the Member's service to the Club over a sustained period (no less than 10 years' service) in a range of different areas of the Club or who has shown significant and outstanding achievements in one particular area for an extended duration. The individual's contribution demonstrably enhances the development of the Club.

In special and extenuating circumstances, the Honours Panel by unanimous decision may recommend to the Board of Directors, to name an award, room, or a piece of equipment after a Club Member who warrants this honour due to rendering special and outstanding service to the Club, without the requirement of ten (10) years' service, but this would be for exceptional circumstances only.

## 8.1. AWARDS

### **Geoff Newman Club Person of the Year Est: 2003**

The Club Person of the Year Award was named in honour of Geoff Newman in 2016. Geoff was the ultimate club person, a quiet achiever with a club first attitude who worked tirelessly behind the scenes, had time for every member of the club and no issue was too big or too difficult for Geoff to address.

Service Record and Awards:

- Director of Administration 2009 to 2014, Club Person of the Year 2011, SLSWA Administrator of the Year 2012.

### **Murray Club Family of the Year Est: 2024**


